#### 5.3 Advice for firefighters

#### 7.1 Precautions for safe handling

#### **Protective measures**

: Put on appropriate personal protective equipment (see Section 8). Do not breathe dust. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid release to the environment. #### 8.2 Exposure controls

# Appropriate engineering controls

: Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapour or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
