4.1 Description of first aid measures

4.2 Most important symptoms and effects, both acute and delayed

5.3 Advice for firefighters

7.1 Precautions for safe handling

8.2 Exposure controls

Appropriate engineering controls : Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapour or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. Skin protection
