Ingestion

Wash out mouth with water. Remove dentures if any. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Get medical attention. Never give anything by mouth to an unconscious person. 4.2 Most important symptoms and effects, both acute and delayed

5.3 Advice for firefighters

8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation.
